
Sub:- Proposed Bill on Genocide of Hindus in Kashmir for the perusal
of Prime Minister.

We, the Hindus of Kashmir living outside India have recently constituted an international initiative 'Panun Kashmir-Initiative on Reversal of Hindu Genocide in Kashmir' (PK REHINGE Kashmir). On the occasion of Kashmiri Pandit Holocaust Day, commemorated on 19 January, 2020, we hereby forward the proposed Bill 'Panun Kashmir Genocide and Atrocities Prevention Bill 2020' drafted by Panun Kashmir and released on 28 December 2019, at Jammu for your perusal so that it be adopted by the Parliament of India.

The entire community of Hindus of Kashmir living in India and outside, appreciate and endorse the epochal measures taken by Government of India under your leadership. For us the epochal change started happening with the clearance of Balakot operations against Pakistan. It changed the strategic thrust of Government of India while dealing with Pakistan which was relentlessly pursuing a proxy war against India feeling secure in its self nurtured illusion of the nuclear deterrence that it thought it possessed.

The neutralization of Article 370, abrogation of 35-A and reorganization of Jammu and Kashmir state into two Union Territories was a revolutionary liberating decision. It deprived Pakistan the spring board inside India to wage war against India. This decision of Government of India under your leadership when seen in relationship with another path breaking decision of passing Citizenship Amendment Act, to us, gives a clear impression that you have initiated processes to decisively put a stop on the colonial legacy which we are carrying on our shoulders like an albatross.



Article 370 conferring a special status to Jammu and Kashmir actually created a Muslim State on the territory of secular India. It was a colonial stranglehold which extended to the time till you neutralized Article 370. Inability of government of India to stand up for the non-Muslims running away from Pakistan, Bangladesh and Afghanistan was also reflection of the incapacity inflicted on the nation of India by the colonial powers. You have taken decisive step to Decolonize India for which history of India will remember you.

You must be aware that Panun Kashmir under the leadership of Dr Agnishekhar (Convenor) and Dr Ajay Chrungoo (Chairman) have been on the forefront of endorsing your decisions and first in India to issue this endorsement in the written form signed by 1000 prominent academics, writers, actors, musicians, artists and social activists, till now a unique exercise in whole of India. This endorsement has been widely circulated through press conferences, seminars and distribution of booklet with names of signatories.

Fully aware of our responsibility in this new era initiated through your monumental decisions Panun Kashmir decided to frame the 'Genocide and Atrocities Prevention Bill 2020'. This Bill was framed with the purpose of creating the concrete and clear legal framework to address the tragedy befallen upon Hindus of Kashmir commonly known as Kashmiri Pandits so that the issue is no longer addressed as migration and instead addressed within the framework of permanently reversing the Genocide. The Bill was also framed and released at this critical juncture to state emphatically and in all seriousness that Hindus of Kashmir were subjected to Genocide in Kashmir so that the whole world knows that the separatist movement in Jammu and Kashmir has been actually a genocidal campaign which is gradually spilling over into Jammu and rest of India. World at large has to be told that the separatist movement in Jammu and Kashmir was never a freedom struggle but an assault on the freedom of people living in Jammu and Kashmir. We are aware that your government has already taken the first resolute step in recognizing that Hindus of Kashmir have actually not migrated but were forcefully expelled by unleashing genocide on them. We have appreciated that while elucidating the reasons for ban on Jammu and Kashmir Liberation Front your government has clearly stated that the terrorist organization banned was responsible for inflicting Genocide on Kashmiri Pandits.

We also feel it very important to bring to your notice that Hindus of Kashmir not only were subjected to Genocide in Kashmir but also subjected to Denial of Genocide in exile in rest of India. The previous governments in Jammu and Kashmir and New Delhi were complicit in it. Denial of Genocide is actually the continuation of Genocide and in fact the climax of the genocidal war. Experts call it as double killing.


Panun Kashmir's International Initiative On Reversal Of Hindu Genocide In Kashmir


We once again urge you to initiate measures to address this Bill and initiate measures that Parliament of India passes it as Act in the nearest future.


